### Registration Terms & Conditions

#### 1. Defined Terms and Interpretation

1.1. Capitalized terms in these terms and conditions have the meaning given to them in the dictionary at paragraph 10.

#### 2. References to Nashville Time

2.1. Any reference to time in this document is to the time measured in Nashville, Tennessee, US. It should be noted that Nashville, TN-US measures time by reference to US Central Daylight Time (CDT).

#### 3. Insurance and Liability

3.1. All players must be covered by individual insurance with cover extending at least for the full period of the Tournament. No player may take to the field in any game played as part of the Tournament unless player insurance has been secured. Insurance must not exclude injury or loss arising from the game of rugby union.

3.2. The Bingham Organizers do not provide player insurance for participants or take any responsibility for ensuring the validity or extent of any individual player's insurance cover. By registering, each registrant accepts responsibility for ensuring the adequacy of any relevant insurance.

3.3. The Bingham Organizers will accept no liability for bodily injury, illness or death of any registrant and or loss of or damage to personal effects arising out of or in connection, whether directly or indirectly with the Tournament or any Bingham Cup 2016 Event.

#### 4. Tournament Rules

4.1. Prior to the commencement of the Tournament, International Gay Rugby (**IGR**) will publish rules relating to the conduct of the Tournament, including disciplinary matters (**Tournament Rules**).

4.2. All registrants must comply with the Tournament Rules, and registration for and participation in the Tournament is subject to that compliance.

4.3. The Bingham Organizers will not be liable for the outcome of any disciplinary matter or its resolution in accordance with the Tournament Rules, including any exclusion of any registrant, whether player, official or supporter from the Tournament.

4.4. The Bingham Organizers reserve the right to exclude any registrant from the locations at which the Tournament is to be played if any such exclusion is undertaken in accordance with the Tournament Rules

#### 5. Registrations – Allocation of Names to dummy registrations and transfers

5.1. Bulk registration fees are non-refundable and no refunds will be provided.

5.2. Where a registration has been made by allocating dummy names (such as "Dummy1", "Dummy 2" etc.), individual names and other player information should be allocated to each dummy

registration by midnight on April 1<sup>st</sup> through the Sport Ngin site or by emailing info@binghamcup.com. Final roster are due by Friday May 20, 2016. No transfer can be made after midnight on May 20, 2016.

- 5.3. Any transfer of a registration to another individual should be made by midnight on April 30 2016 by emailing info@binghamcup.com.

## 6. **Bingham Sponsors and Partners**

- 6.1. No registrant shall breach or infringe the rights of any Bingham Sponsor, do or cause anything to be done which might reasonably cause offense or embarrassment to any Bingham Sponsor or do or cause anything to be done which might reasonably bring any Bingham Sponsor into disrepute.

## 7. **Bringing the Tournament, the Bingham Organizers or IGR Into Disrepute**

- 7.1. No registrant shall do or cause anything to be done which might reasonably cause offense or embarrassment to the Bingham Organizers or IGR or do or cause anything to be done which might reasonably bring the Tournament, the Bingham Organizers or IGR into disrepute.

## 8. **Photos and Images**

- 8.1. The Bingham Organizers, IGR and Bingham Sponsors may wish to film or record the whole or parts of the Tournament and or the whole or parts of Bingham Social Events in various electronic, digital, physical and other media formats. By registering, each registrant consents to the Bingham Organizers, IGR and Bingham Sponsors their employees, agents and contractors taking photos, videotape, digital or other similar recordings of the registrant and further consents to the registrant's name and identity being revealed by descriptive text or commentary.
- 8.2. Each registrant consents to the Bingham Organizers, IGR and Bingham Sponsors, their employees and agents exhibiting any such recordings publicly or privately and marketing or selling copies of any such recordings.
- 8.3. Each registrant waives any rights, claims or actions that the registrant may have to control the use of the registrant's identity or likeness in whatever media is used and forever releases the Bingham Organizers, Bingham Sponsors and Bingham Partners, their employees, agent or contractors in respect of the use or sale of any such image.

## 9. **Dictionary**

- 9.1. Capitalized words and phrases in these terms and conditions have the following meanings:
- **Bingham Organizers** means Bingham Cup 2016 or Nashville Grizzlies RFC Inc., whether jointly or severally as the case may require
  - **Bingham Sponsor** means any sponsor or partner of any Bingham Organizer, any sponsor or partner of the Bingham Cup 2016 or any sponsor or partner of any Bingham Cup 2016 Event.
  - **Bingham Cup 2016** means the gay and inclusive biannual rugby union tournament to be held in Nashville in May 2016 including any organized transport to or from that tournament
  - **Bingham Cup 2016 Event** means any social event organized by or in association with any Bingham Organizer or any Bingham Sponsor in association, whether directly or indirectly, with the Nashville Bingham Cup 2016.
  - **IGR** stand for International Gay Rugby, also doing business as the International Gay Rugby Association & Board

- **Tournament** means the gay and inclusive biannual rugby union tournament to be held in Nashville in May 2016 including but not limited to any organized transport to or from that tournament.
